

Introduction

Commencing 1 July 2013, the Queensland Government introduced new programs for training delivery that sit outside existing employment-based apprenticeship and traineeship training arrangements called the **Certificate 3 Guarantee** and **Higher Level Skills**.

As part of this program, Target Training receives Queensland Government funding from the Department of Education, Training and Employment, and student contribution fees.

Participant Eligibility

The **Certificate 3 Guarantee** is for students wanting to complete a Certificate level III course. The **Higher Level Skills** is for students wanting to complete a selected Certificate IV level course. There are also selected Certificate II level courses for those unable to complete at Certificate III level. Year 12 leavers can complete a qualification completely fee free. An eligibility criteria applies for each of these opportunities.

The general eligibility criteria for all students:

- Must not hold or be already undertaking a certificate III or higher level qualification (certificate III qualifications completed at school are not counted), for a Cert III Guarantee funded course
- Must not hold or be already undertaking a certificate IV or higher level qualification, for a Higher Skills funded course
- Must be 15 years of age or older
- Must have finished secondary school or left school
- Must be a Queensland resident - an Australian Citizen or permanent resident living in Queensland, or a New Zealand citizen permanently residing in Queensland.

Employment status can vary as long as it satisfies the qualification requirements. Recipients can be unemployed and seeking work, or be working on a full time, part time, self employed or casual. There is also no minimum education requirement, only the standard entry requirements for the course of study.

Year 12 Fee Free

If you are a recent school leaver or nearing the end of Year 12, you can complete a Certificate III qualification completely free of charge. Build professional confidence, boost your skills and increase your career opportunities. Qualifying criteria includes:

- Providing evidence of completing Year 12 in QLD
- Enrolment and course commencement within 12 months of graduating from Yr 12.
- Being a permanent resident/Australian citizen/New Zealand citizen who resides in QLD.
- Not currently studying a Certificate III qualification or higher.

Note: qualifications can be delivered during December to February period so all school leavers heading to University or their gap year may be qualified before the end of February.

Target Training offers SIT20216 Certificate II in Hospitality and SIT30616 Certificate III in Hospitality as a Year 12 fee free arrangement. Practical hours are required to complete these qualifications. Please contact us for more details and workshop course dates.

Concession Eligibility

Under these programs, concession participants are defined as follows:

- (a) The participant holds a Health Care concession card or Pensioner concession card issued under Commonwealth law or I am the partner or a dependent of a person who holds a Health Care concession card or Pensioner concession card and I am named on that card
- (b) the Participant holds an official form/letter under Commonwealth law confirming that I am entitled to concessions under a Health Care concession card or Pensioner concession card or I am the partner or a dependent of a person who holds such an entitlement
- (c) the Participant is an Aboriginal and Torres Strait Islander person

The definition of a Concession Participant below only applies when the Participant or participant's family or guardian is responsible for the payment of any Student Contribution Fee. When a Commonwealth Government agency (e.g. Jobs Services Australia Provider) is using Australian Government funding to pay student fees on behalf of the Participant, then no concessions are to apply.
